Anderson said that MDOT has set their Safety Performance Measures Targets. BCATS will have until February 27, 2018 to set their targets. Anderson provided a handout with the methodology used by MDOT to set their performance targets for review with the recommendation that BCATS consider supporting the State Performance Targets for the Safety Performance Measures.

# **EMCOG Report - Governor's Regional Prosperity Initiative Update:**

Engelhardt provided and update on the Governor's Regional Prosperity Initiative. Through this initiative they have been able to bring a variety of people to the table to participate in the discussion on improving economic development in the region through initiatives such as talent attraction and retention and improving accessibility to jobs, healthcare, and education to the local population. EMCOG is in the process of submitting their application for 2018 funding.

#### **EMCOG Letter of Support for Governor's Regional Prosperity Initiative:**

Anderson provided a draft letter of support for review, with the recommendation that the BCATS Chairman sign the letter. This letter is to support EMCOG in their 2018 grant funding application.

- Addition of M-25 Bridge CPM Project (M-25 over CM Railroad in Bay City) to FY 2018
- 2. Addition of **Region-Wide Systematic Improvements Project** (various locations) for roadside facilities preservation (PE Phase) to FY 2018
- 3. Addition of **Region-Wide Systematic Improvements Project** (various locations) for roadside facilities preservation (CON Phase) to FY 2018
- 4. Increase in Federal and State Costs for the FY 2018 *Trunkline Traffic Operations or Safety Project GPA Project* 
  - Addition of the Region-Wide Delineation Upgrades (various locations) for traffic safety (PE Phase) to the GPA
  - Addition of the Region-Wide Delineation Upgrades (various locations) for traffic safety (CON Phase) to the GPA
  - Addition of the Retro Reflectivity Assessment Project (region-wide) for retro reflectivity readings and condition assessment to the GPA
  - Addition of the Region-Wide Pavement Markings Project (region-wide) for Special Pavement Marking Application (PE Phase) to the GPA
  - Addition of the Region-Wide Pavement Markings Project (region-wide) for Special Pavement Marking Application (CON Phase) to the GPA

#### **2017 BCATS Annual Report:**

Anderson wanted to remind everyone that staff will be working on the 2017 BCATS Annual Report. If anyone has photos and project descriptions, please submit them to Jay Anderson or Brian Stark. This is our chance to showcase our 2017 projects. Anderson spoke with MDOT and we only have to put a notice on MLive that the report is out on our website. This will save money since we won't have to publish the entire report. Malkin mentioned using the Valley Farmer.

#### **Project Updates:**

The City of Bay City **Patterson Road Project** (Smith St to Marquette Ave) for reconstruction will be completed November 11, 2017. The **Independence Bridge Project** (Preventative Maintenance) has started and will continue until November 18, 2017. Work will start back up in January 2018. This project should be completed by April 2018. The **Trumbull Street Project** (Center Ave to Woodside Ave) has been designed following city standards and will have an August 18<sup>th</sup> Let. Most of this project will be done in 2019. The Monitor Township Traxler Court Project has been completed. The Monitor Township Haberland Court Project to work on the storm sewers and drains has been completed.

## **Other/New Business:**

# Transportation Asset Management:

The Transportation Asset Management Council is looking at MPOs that don't use all of their allocated funds in order to shift funding to MPOs that can use the additional funding. When submitting for the quarterly bills, MPOs should be reviewing what all they can bill for in order to maximize funds.

# Bay City Bridges Meeting:

There will be a special bridge meeting for City of Bay City Commission to discuss options for Liberty and Independence Bridge ownership and maintenance on October 30, 2017 6:00 p.m. at City Hall.

# MDOT Regional Non-motorized plan meeting:

Engelhardt said that EMCOG is working with MDOT to update their non-motorized plans. A public meeting will be held October 30<sup>th</sup> from 5-7 p.m. at the MDOT Bay region office in Saginaw, MI.

# **Environmental Assessment of Projects:**

Anderson said that there will be an Environmental Assessment component to local projects submitted to MDOT Local Agency Programs coming up in the future. While there's nothing set right now, it will be coming up soon. MDOT Local Agency Program staff are seeking comments from Act 51 agencies on the proposed Environmental Assessment process.
