## Overall Transportation Investment in BCATS Area at \$46.2 Million in FY 2023; Emphasis on Safety Funding.

BAY CITY, MI., December 22, 2023- The Bay City Area Transportation Study (BCATS) has released its Annual Obligation Report, showing Federal funding obligated in the BCATS area for Fiscal Year 2023 for roads, bridges, and transit. State and Local funds are included in the report for reference where possible.

## The 2023 BCATS Annual Report:

- Shows that overall transportation investment in the BCATS area is up significantly from FY 2022, although that year was aided by large investments in transit.
- Federal funding was largely focused on roads and bridges, at 46.1 million dollars, with state highways still being the largest beneficiary, along with over 7.5 million dollars in Federal transit funding.
- Overall transportation funding totaling over \$82 million was invested into the BCATS area transportation network through Federal, State and Local sources.
- State of Michigan investment in the area increased greatly due to highway reconstruction on US-10, that will be continued in FY 2024.

The list also helps to monitor the progress and performance of the projects and to evaluate their impact on the transportation system and the environment.

The Bay City Area Transportation Study is the Metropolitan Planning Organization (MPO) for the Bay City Urbanized Area, a multi-jurisdictional organization representing the cities of Bay City and Essexville, along with Kawkawlin, Monitor, Bangor, Hampton, Portsmouth and Frankenlust Townships.
