**JOB TITLE:**                   **MECHANIC/SPRAY TECHNICIAN**

**RATE OF PAY:**               \$15.09 per hour entry, progressing to  
\$17.91 per hour after 4 years (TS07)

This is a part-time position (up to 29 hours per week - subject to change with the seasons) with limited benefits as provided for within the USW part-time labor agreement, although union membership is voluntary.

**GENERAL SUMMARY:** Under the direct supervision of the Greens Superintendent, performs a variety of tasks to preserve grounds and turf of Golf Course in playing condition. Services and repairs mowing and irrigation equipment. Job does not have primary responsibility for the direction of other employees.

**ESSENTIAL FUNCTIONS:**

1. Services and maintains mowers by lubricating moving parts, adjusting settings and grinding blade reels.
2. Services and maintains riding golf carts.
3. Drains water lines, shuts off valves, repairs sprinklers and water system leaks, maintains water pumps.
4. Connects hose and sprinkler systems at designated points on course to irrigate fairways and tees.
5. Cuts turf on green and tee areas using hand and power mowers.
6. Operates tractor using special attachments to mow rough, fringe, and fairways at designated cut, using care not to injure turf.
7. Changes holes on greens and grades new greens; grades and cleans sand traps.
8. Cuts and trims trees.
9. Repairs chipped greens by seeding and sodding excavated areas.
10. Sprays greens, fairways, roughs and trees with fungicides, insecticides, and fertilizers.
11. May provide oral directions to part-time workers assisting with work projects.
12. Must be able to move / lift heavy objects.
13. Punctual and consistent attendance is an essential function of this position.
14. All other duties as assigned.

The above statements are intended to describe the general nature of work performed by people assigned this classification. They are not to be construed as an exhaustive list of all job duties.

**QUALIFICATIONS:** This position requires proper knowledge of various fertilizers and soil conditions, herbicides and pest control methods and materials. Requires knowledge in safe mechanical operation/calibration of the following types of equipment: Mechanical pressurized spray equipment; hand operated spray equipment; rotary spreaders; drop spreaders; utility tractors and mowers. Must have some mechanical knowledge on how to operate and repair golf carts and various types of mowers used on the fairways and greens. Requires current State of Michigan herbicide / pesticide applicators certification. Also, must hold a valid State of Michigan drivers license.

**PHYSICAL REQUIREMENTS:** This position requires sitting, being mobile, bending and/or standing for significant periods of time. Additional requirements include the ability to move objects according to the following weight & frequency: Generally, 20-100 pounds of force up to 1/3 of the time.
