Dear Governor Whitmer:

Bay-Arenac Behavioral Health (BABH) is a multi-county community mental health program (CMHSP) serving more than 5000 residents of Bay and Arenac Counties on an annual basis. The purpose of this correspondence is to ask you to urge the Michigan Department of Health and Human Services (MDHHS) to halt the implementation of its current approach to meeting the Federal Conflict-Free Access and Planning (CFA&P) requirements related to Medicaid mental health services.

CFA&P is a federal requirement at 42 CFR § 441.730(b)(5) designed to limit perceived conflicts of interest for beneficiaries obtaining certain Medicaid Home and Community-Based Services (HCBS). The minimum conflict of interest standards require that the service provider is not a relative of the individual or responsible for the individual's finances or health-related decisions, nor hold a financial interest in any of the entities that provide care. It is important to note that most of the federal pre-print dialogue on CFA&P was predicated on concerns of pecuniary conflicts involving private, for-profit provider systems.

The CMHSP system has its foundations in a State and County partnership to fund and deliver public mental health services in Michigan per MCL §330.1116(2)(b), 1206, 1302 and 1308. This included a deliberate decision to close state hospitals and integrate individuals into the community nearly 60 years ago. This is based on a statutory transfer of care responsibility for individuals with a serious mental illness, developmental disabilities, or serious emotional disturbances from the state to the 83 county governments under the law.

This policy was subsequently expanded to permit counties to assume full management responsibilities, create community mental health authorities and implement regional managed care programs under Medicaid waiver authorities. MDHHS is now erroneously re-interpreting this long-established legislative policy to imply that in *some* instances county CMHSPs have a pecuniary conflict of interest for *some* of the services included in this delivery system.

MDHHS has insisted on this position despite the fact that valid concerns have been raised in multiple venues during the last two years including stakeholder meetings, state-wide planning discussions, and the formal Medicaid policy promulgation process. It should also be noted that the Federal Center for Medicare and Medicaid Services (CMS) has already approved CFA&P designs in other states similar to Michigan (including other parts of Michigan's existing Medicaid waivers) within the safeguards of our current state and county partnership for public services.

The MDHHS CFA&P position also ignores the comprehensive CMHSP service requirements under MCL §330.1206, disregards the importance of consumer/family choice of providers, adds unnecessary administrative duplication and expense to the Medicaid program and perhaps most egregious of all, implies that a hidden CMHSP profit incentive would supersede our statutory duty to the communities that we have the privilege to serve.

CMHSPs are non-profit governmental organizations with statutorily defined obligations that mitigate against the likelihood of a pecuniary conflict of interest. These include direct accountability to the community through a public board, open meetings, a guaranteed recipient rights appeal & grievance system, established independent person-centered planning facilitation requirements, and expanding availability of consumer self-determination/self-directed options.

In addition, CMHSPs are prepaid on a capitated basis through a shared regional risk contract with the State, preventing any direct pecuniary relationships to assessment, planning and case management services and/or the volume of services delivered. These contracts are cost settled each year, include restrictions on the use of surplus and/or Internal Service Funds (ISF) and require unspent funds be returned to the State. These funds do NOT lose their Medicaid identity as in a contract with a private interest and are still subject to public accounting requirements.

We urge you to request MDHHS to rethink their proposal for the CFAP requirements. The intended October 1, 2024 deadline is going to create unnecessary havoc throughout the CMHSP provider systems and have absolutely no benefit to the consumers and families receiving care. There are other pathways to compliance with CFA&P requirements that would build on the existing State and County partnership and be a much easier transition for all stakeholders. Please also know that the Community Mental Health Association of Michigan (CMHA) is available to assist MDHHS or your office in finding a mutually beneficial resolution to these policy concerns.

WHEREAS,	Nearly 5,000 Bay and Arenac County residents and their families with serious mental illness, intellectual/developmental disabilities, addictive disorders, and children with severe emotional disturbances depend on the public mental health system and its community partners for both acute and long term supports and services; and
WHEREAS,	Bay County supports a CMHSP safety net that carries out its obligations to every citizen by prioritizing and serving persons with the most severe and persistent forms of mental illness, intellectual/developmental disabilities, and addictive disorders in the context of broader public health and safety instead of short term considerations of private gain and profit; and
WHEREAS,	The Michigan Department of Health and Human Services (MDHHS) is applying Medicaid requirements for Conflict Free Access & Planning for the purpose of re-interpreting this established legislative policy to erroneously imply that in some instances county CMHSPs have a pecuniary conflict of interest for some of the services included in this delivery system; and
WHEREAS,	CMHSPs are instruments of county government with statutorily defined obligations that mitigate against the likelihood of a pecuniary conflict of interest. These include direct accountability to the community through a public board, open meetings, a guaranteed recipient rights appeal & grievance system, established independent person-centered planning facilitation requirements, and expanding availability of consumer self-determination/self-directed options; and

Dear Mr. Begick and Fellow Commissioners,

As required by Region VII Area Agency on Aging (R7AAA), included is this brief narrative and the budget for the programs we are requesting FY25 funding. The R7AAA allocation for Adult Day Care is \$88,896 and Caregiver Training is \$17,986 for a total of \$106,882. This is a \$2,700 increase over the previous year's allocation. While a nominal increase, this enables us to provide additional services to families caring for a member with a dementia disorder. We project to provide 8,979 hours of adult day care services to 32 families and 555 hours of training to 90 family caregivers. While R7AAA is our primary source of funding assistance, we also receive funds from the United Way of Bay County, A&D Home Health Care and the Veteran's Administration to assist caregivers in paying for services.

Golden Horizons Adult Day Care Center is the senior component of the Bay County Child & Senior Citizen Centers, Inc., a private, non-profit agency that operates two day care centers. Located in the inter-generational Fremont Center, Golden Horizons has specialized in providing an array of supportive services to individuals with Alzheimer's disease and related dementia disorders, and their families since opening in 1988. The program operates from 9:00 a.m. to 5:00 p.m. Monday through Friday.

The majority of care for older adults is provided by families in their homes with their own financial resources with many lacking the knowledge and understanding of dementia disorders. Initially a person with Alzheimer's disease starts with memory loss, however, eventually they need assistance with bathing, dressing, eating, walking, toileting, getting in and out of bed or a chair, and become unable to perform the simplest of tasks. Besides requiring help for routine tasks they may become restless, uncooperative, combative, belligerent, paranoid, delusional, verbally or physically abusive, experience hallucinations, have personality changes, become incontinent of bowel and bladder, wander and require 24-hour supervision for safety.

Using an adult day care program can help reduce the tremendous physical and emotional distress caregivers experience when caring for a family member with Alzheimer's or other dementia disorders. The caregiver can continue working, perform household tasks, participate in leisure activities, or just have a break from their caretaking responsibilities. The person with Alzheimer's/dementia benefits from the variety of activities, socialization, nutrition, and health monitoring, in a supervised setting during the day and returns to the comfort and familiar surroundings of their home at night.

Caregiving takes a toll on families especially when there is a lack of resources. Research indicates that the availability and utilization of affordable community based services enhances the physical and

mental health of the caregiver and their ability to provide care at home. The cost of adult day care is nominal in comparison to costly assisted living and nursing home care. The R7AAA adult day care funding enables us to offer financial assistance to families, thereby extending their resources, and helping them to access care services and delay the placement of their loved one in a care facility. Those receiving financial assistance are given the opportunity to share in the cost of services based on a sliding fee scale ranging from \$1.50 per hour up to \$10.50 per hour for families above 185% of the federal poverty level. Those below the poverty level utilizing the adult day program are provided the opportunity to make a contribution. While the private pay rate for services increased from \$9.50 per hour to \$10.50 per hour as of April 1, 2024, the majority of families receive funding assistance.

The Caregiver Training funds are utilized for providing dementia education classes, daily support for caregivers using the adult day program, providing information, referral and linkage with community services, and counseling. The classes are now offered in-person since April. We feature one topic every month with the in-person choice of morning or evening, and a virtual class via Zoom in the afternoon. The morning session offers free adult day services by reservation. The dementia care topics include Overview of Alzheimer's, The Other Dementias, Communicating Effectively, Managing Difficult Behaviors, Stress & You, Pain & Dementia and Dementia and Diabetes. Additional topics are offered or developed, based on demand. The funding also supports the staff costs associated with providing a monthly Alzheimer's/dementia caregiver support group and individual and family counseling for family caregivers. When caregivers learn how to take care of themselves they become more effective in managing their daily responsibilities. Additional benefits of training include increased knowledge of the disease process, effective communication skills, successful management of challenging behaviors, increased awareness and use of community services, a decrease in stress, guilt and anger, and overall improvement in coping skills. All Caregiver Training activities are provided at no cost to participants.

Professional staffing for the program includes a full-time Program Coordinator, a Licensed Master Clinical Social Worker with 48 years of geriatric experience, who also facilitates the caregiver support group. The full-time Licensed Practical Nurse, with 30 years of geriatric experience, provides medical oversight of program participants, assists in the adult day program, and is the Dementia Educator for the caregiver training classes. Support staff includes one part-time Office Assistant, three full-time and one part-time adult day care Program Assistants. The program annually serves approximately 40 families with a daily capacity of fifteen program participants.

Golden Horizons maintains collaborative relationships with numerous human service agencies throughout Bay County and especially with the Bay County Department on Aging and Region VII Area Agency on Aging. We will continue efforts of outreach and marketing to Region VII AAA's target groups; individuals who have cognitive impairment; need assistance with three or more activities of daily living; are a minority; are a low income minority; and those in greatest economic and social need. The Region VII Area Agency on Aging funding enables us to continue providing these essential services to families in Bay County.
